Product Description

The STC INTUMESCENT INSERTTM is an electrical outlet box insert, a one component fire rated pad that is placed on the inside back wall of an electrical box. It is a highly intumescent firestop material that, when exposed to fire, expands to form a char that will seal off the opening and prevent the spread of flames and limit the temperature rise on the unexposed surfaces.

Applications

FIRE PROTECTION:

The STC INTUMESCENT INSERT[™] is certified and listed by Underwriters Laboratories as a wall opening protective material. It can be used for outlets in 1-hour and 2-hour fire-rated partitions to meet the "24-inch rule" (IBC 714.3.2 Exception 1.5). Fire partitions are typically used as demising walls in multifamily apartments and other residential construction.

NOISE CONTROL:

The STC INTUMESCENT INSERT[™] provides minimal improvement for sound isolation, similar to putty pads and other outlet box inserts. Use the STC BOX SEAL[™] for high performance acoustical sealing of recessed electrical outlets.

Include in Section 262726 "Wiring Devices" or in Section 078413 "Penetration Firestopping":

Electrical Outlet Box Insert: Manufacturer's standard intumescent firestop material to fit interior of metal outlet boxes; tested per UL 263/ASTM E-119 and certified as a wall opening protective material; STC Intumescent Insert.



Installation

Make sure rear interior surface of outlet box is clean, dry and not contaminated. Remove protective paper from tape and stick pad to inside back wall of electrical box prior to installing wires or devices. Center pad from top and bottom of box. Use the single pad for a single box (2" x 3"), and double pad for a double box (4" x 4"). Limit wire number and size to comply with NEC 314.16 (formerly 370.16) or other applicable codes.

Availability

Single (1-Gang) for 2x3 outlet boxes. Double (2-Gang) for 4x4 outlet boxes.
